

## **RADFORD K-9 SPORTS CENTRE COVID-19 CLASS GUIDELINES**

Radford K-9 Sports Centre (referred to as RK9) and students need to stay current and follow government guidelines.

Please be aware that currently, it is up to you to maintain physical distancing guidelines when attending classes.

If you are ill, please stay home. If RK9 deems an exhibitor ill at the event, they have the option to excuse that student. Refunds will be given for Covid-19 illness.

Make sure your dog is ok with people wearing masks. We don't want a dog becoming fearful due to something they've never seen before.

**ADDITIONAL WAIVER:** Radford K-9 Sports Centre will have an additional waiver that all students and guests attending must sign. Each student/guest must sign and return the form electronically or present the waiver to RK9 upon arrival or they cannot participate in the class

**GLOVES:** Gloves are an individual choice. Studies show frequent hand washing is better than gloves in many cases. If as a student, you prefer to wear gloves, you will need to bring enough for the times you will need to wear them. You may also be required to use sanitizer on the gloves if you have touched the equipment. Please dispose of gloves properly.

**MASKS:** Masks are required, and government guidelines. Students will need to bring enough masks for the duration of the trial and dispose of single use masks properly.

**BATHROOMS:** Bathrooms will not be available during class. Please be sure to use the washroom before coming to class. Please bring your own sanitizer/wipes. Some will be available on site.

**CRATING & SPECTATING:** Please bring your own chair/crate/water bowl/treats. One student per dog, guests will not be allowed on premises during class. If it looks like rain, you will have to supply your own umbrellas'.

Where possible the instructor will handle all equipment changes.
